Step 8: Membership ID card(s), a partial provider list, and membership materials that include the fee schedule will be mailed to each employee that has enrolled in your group dental plan; within 5-7 business days of the activation date. All active employees can begin using their New Dental Choice memberships as soon as they receive their membership materials!
